Anyone not listed will be denied entry unless you have given the Gate Personnel prior authorization. Service providers and up to three (3) guests have the option to purchase a transponder by making separate application to Gateway Greens. Renters/tenants are not authorized a permanent vendor/guest list. Service providers with transponders will be allowed automated access into Gateway Greens through the Westlinks, Hidden Links, and Walden Lakes gates during the hours of 7:00 a.m. to 6:00 p.m., Monday through Saturday. Permanent guests with transponders may access any of the gates at any day or hour. The Protective Covenants for Gateway Greens apply not only to all members, but also to those to whom a member has delegated his/her right of use. **In addition, the member is responsible for any and all violations committed by anyone to whom he/she has authorized access, and is also responsible to notify the property manager in a timely manner of any deletions of parties no longer eligible for access to the community.** It is the duty of the member to notify any invitee of the covenants, conditions, restrictions and other provisions of the Declaration (Article 3.32 a & b). All other access must be scheduled through the Main Gate.
